Meeting of minds

In order for us to achieve your picture ideas we would need to meet with you and your fiancée prior to your wedding day to discuss the finer details of photographing your wedding. We would then like to book a date to shoot the pre-wedding images, where we photograph the two of you, this helps you to relax with us and you get three 9 x 6 inch photo mounted prints free. Parents are welcome at this meeting of minds.

Sole Photographers

We have no objection to amateur photographers taking pictures as long as they do not interfere or interrupt the official photography. It is understood we are the sole professional photographers in attendance. The photographer shall be granted artistic licence in relation to the poses photographed, location used and the number of images taken and as such the photographer's judgments' shall be deemed correct.

Copyright/advertising

With reference to the Copyright and Patents Act of 1988. The copyright of all photographs taken by HRphotoimages photographers remains the sole property of the business. Signing this contract means that you fully agree that the photographs taken by HRphotoimages may be submitted to any photographic competition or newspaper with a view to publication or display in a portfolio of work or otherwise used for promotional purposes. The rights under sections 77 and 80 are hereby asserted. **IT IS CONTRARY TO THE ACT TO COPY OR ALLOW TO BE COPIED ANY PHOTOGRAPHS COVERED BY THIS CONTRACT.**

Photographs

All photographic sizes are nominal. HRphotoimages will endeavour to provide a pleasing colour balance but cannot guarantee an exact colour match. This is due anomalous reflectance caused by certain dyes and materials, especially man-made fibres, it is sometimes impossible to record an exact colour match as seen by the human eye.

Payment

A deposit of £180 is payable at time of booking to secure wedding date. 50% of the remaining balance to be paid thirty days before the wedding date. The outstanding balance is to be paid at the time that the wedding package is completed. Please note that if the outstanding balance is not paid in full then the package items will not be released.

Payment for additional prints, photographs in frames etc to be paid in full on placement of order.

Wedding albums

The preview album will be loaned to the bride and groom for a period of eight weeks and remains the property of HRphotoimages.

Complaints

In the unlikely event of an unresolved complaint we agree to the British Institute of Professional Photographers to act as an arbitrator their decision will be binding on all parties.

Cancellation

The client may repudiate this contract at any time by given written notice to HRphotoimages. Should notice of the cancellation be received by HRphotoimages less than eight weeks prior to the appointment the clients should pay HRphotoimages seventy five percent of the current price of the minimum wedding package specified in our literature. The said sum shall be payable as compensation, it being agreed as an estimate of the loss HRphotoimages would suffer. **THE DEPOSIT IS NON-RETURNABLE.**
